Board Meeting 1 - The Space Corporation
Meeting Minutes

Summary of Action Items (from Minutes below):

1. Onboarding Committee: Establish a clear onboarding process for new members, including a member workflow and response templates.
2. Delete public Telegram group: Close the public Telegram group after promoting the new website and RMB Telegram group for member development.
3. Amend Charter: Update the charter to prioritize and promote the use of free and open-source software (FOSS), and make changes to the decision-making process in Article 2.
4. Zach: Devise an action plan for federal filing of non-profit entity.
5. Tech Infrastructure: Set up a trusted location with cleartnet access for the server hardware, and have Anthony and David C. communicate about server hardware.
6. Member Onboarding Dues Payment Policy: Create more clarity and tighten up language for dues payment policy.
7. Budget/forecasting: Move to table vote on budget in future board meetings.
8. Create Member Handbook: Develop a handbook that includes information on removing members, dues payment policy, and other relevant policies.
9. Box Elder RE Location: Look into other available office spaces in the building.
10. Setup dinner with Board & Donor for Franklin RE discussion: Organize a dinner meeting with the board and a donor to discuss the Franklin RE project.
11. Limiting committee scope - add to charter: Include language in the charter that limits committee scope.
12. Press Kit for Members: Create a press kit for members to easily share information about The Space.
13. Nashville Side Events: Plan side events for members and new interest during the Bitcoin conference in Nashville.
14. Get Odell, Rod (others?) to provide speaking platform/marketing at Bitcoin Park: Collaborate with Odell, Rod, and other individuals to provide a speaking platform or marketing opportunities at Bitcoin Park.
15. Policies: Be aware of any red flags, gripes among members or board, and avoid being over-bureaucratic in governance.

Meeting Minutes:

Zach' opened the meeting review Principles & Vision

Principles:

- Individualism
- Voluntary Association
- Right to Privacy
- Software is Speech
- Proof of Work

- Meritocracy
- Curiosity
- Courage
- Authenticity

Vision:

- Further the use of Bitcoin (BTC) as a Store of Value & Medium of Exchange

Updates:

- 3 new members joined The Space on the night of the Halving party

Commitments:

- Maintain Principles and Values outlined above, in the Charter, and the soon-to-be-created Member Handbook
- Events - currently budgeted at least 1 per month, but will increase with new member onboarding
- Operate on a complete Bitcoin standard for the first decade of existence
- Solely use Free and Open-Source Software (FOSS) within the first decade
 - Stipulation: If FOSS prohibits specific functioning and creates inefficiencies, then non-FOSS will be used
- Amend Charter: "Prioritize and promote the use of FOSS, where possible"
 - Motion to amend carried unanimously
- Prioritize shared goals of the members
- Ensure the Donor is explicitly aware that these purposes and values are upheld, and that he is not a central authority in The Space
- These missions and values are being built as a foundation to replicate for future Bitcoin spaces across the US/Globally/throughout Space & Time

Decision Making (Charter Article 2):

- Change to "Majority of the quorum of present board members must make the decision"
- Remove "5"
- If there is a voting tie, the Chairman will have the winning vote

Legal Docs, Filing Status:

- Federal EIN Delay - reason: "technical issues"
- Called the IRS, but got nowhere
- Need to devise an action plan, Zach moving forward on this
- Registered agent has not received any notice
- Can still sign the lease for Real Estate (RE), but cannot open a bank account or get insurance
- Need EIN - stops us from getting a bank account
- Bank Secrecy Act (BSA) requirement to file ultimate beneficial owner of the corporation

- 1023 EZ (Under \$50K Income/~\$200 Gross Receipts) - We don't qualify, need to file full 1023 (\$600)
- Create a filing committee

Budget/Forecasting:

- Current Assets are technically not compliant with the Charter due to not being able to hold 6-months of assets (50% Bitcoin per fixed costs)
- Modeling projects the first year and does not include original dues members paying their next full year
- If we get members when we get RE for The Space, it gives us \$3,800 extra income
- Assuming no growth, then we're out of money in January 2025
- Currently budgeted \$1,000 per month for events
- Lots of guesses currently, so Dylan needs more inputs for proper forecasting
- Currently 27 consistent dues-paying members
- 31 total (with those that paid on the founding night, +1 new member onboarded since)
- At the Inaugural event, new members from that evening could continue payment on their own timeframe, but that model is not sustainable
- Need to figure out a policy to tighten this up
- Other expenses to include in modeling: Cleaning labor, food/drinks
- Goal of 50 paying members
- Dylan's budgeting sheet is built on an assumed 2.5% month-over-month increase in Bitcoin price
- Expenses denominated in dollars and then converted to expected Bitcoin price across that time-frame
- Use of funds: Events versus RE building
- Hope: getting an RE building brings in a minimum of 20 new members
- Current Treasury can serve as a buffer for some timeframe
 - *For scale reference: \$2K was spent at the BitDevs Halving party for food & beverages
- Joel suggested doubling the current utilities projection and increasing the insurance cost
- Budget/forecasting: Motion to table the vote on the budget for a future meeting
- Dylan still needs to discuss budgeting for servers (tech infrastructure) with Anthony
- Consider "Churn" in forecasting
- Should there be Benefits to Members for paying the year in advance versus monthly?
- Additional cost for private offices

Current Membership Stats and Goals:

- 50 members outlined in original goals
- 31 members in the chat, paid in some capacity
 - Most paid on time, but not all
- 1 more popular event away from potentially reaching the 50 members goal
- Want 20 additional members ASAP
- The Halving party showed that people are hungry for Bitcoin communities
- Even people outside of Colorado have been interested in The Space

- At all Events (especially outside of The Space), create time to discuss what is being built and provide organizational updates
- 210 Members as a future goal (timeline to be determined)
- Clear communication - handbook, etc.
- Keep the Member Telegram group active

Membership Suggestions:

- Bitcoin Bay guys recommended \$20 events to educate newbies
 - Still keep member-only events as the main focus initially
- Member termination policy
 - How do we remove a member?
 - e.g., 60 days of non-paying dues, lose grandfather pricing
 - Update in the handbook or Bylaws
 - Add to the next meeting agenda
- Use events to bring in new members locally and those outside of Colorado
- Put Sponsorship amount & info into flyers for distribution to other current Bitcoin meetups
- Mark Link said yes to promote The Space
- Target CU Boulder
 - Discounted student membership tier
 - Volunteer opportunities
- Do we expect more hardcore Bitcoiners or newbies as members?
- Gain more out-of-state supporters
 - We may have more of these than realized (aligned with member-owned values, Principles/Vision, etc.)
- Use Dylan's Twitter/Nostr tactic that got Odell's attention
 - Replicate and get attention of more influential people/OGs

Real Estate:

Current Offerings:

- Box Elder - 1325 S Colorado Blvd, Denver, CO 80222
 - \$3k
 - Finished offices, although smaller event space (larger use with Independence Institute)
 - Maybe useful for us for 1 year max as we build the foundation
 - Maybe co-working space only
 - Or lean on Independence Institute for events
 - Negative - far from most board members (potentially majority of members) & not centrally located
 - Cheapest option, easiest to get into due to relaxed owner
 - Potentially other options in the same building to look at
- Wadsworth (David C's spot)
 - Most but not all members have seen it
- Compass

- Available at the end of May, beginning of June move-in
- \$4,250 + insurance, utilities, etc (about \$5,200 total)
- Donor - Franklin Location
 - Well-funded, long-time Bitcoiner, very supportive
 - \$2.4 million building
 - Verbally agreed to cover rent for 1-2 years
 - We need to pay insurance & maintenance
 - Donor wants us to be a formal tenant
 - We are responsible for Triple Net costs
 - Donor plans to be present at next Tuesday's Formation meeting
 - We need to design a lease, so we are not liable if he were to become insolvent
 - Come up with a dinner proposal for the in-person meeting (board pays their own way; use member funds to pay for Donor's dinner)
 - Will (BlockSpace) might need to be brought into this conversation about needing a podcasting studio in the RE location
 - Tyler: Survey for meeting time for board members and Donor to meet
 - NO Favors; we don't want this RE deal held over our heads
 - Autonomy is the priority

- Bitcoin Bay said Google gave them \$10K per month of marketing space for free due to non-profit status
- Wyatt created email template for turnkey introduction
- Need Member workflow
- Software suite needed to have response templates for interested people
- As we get bigger (higher dollar sponsorship) - have bigger shoutouts, logos, etc. at events, online, etc.
 - Create procedure for this

Design:

- Brand
 - Wyatt's wife will help build the logo
 - Tyler is in communication with her and provided sketches
- Website (expected to go live end of May)
 - Need: member events & non-member events
 - About us: flip image and have small bio per person
 - "Venue" coming soon
 - Link to BTC Maps
 - "Sponsors" under memberships
 - Need CMS that works with Astro
 - Content: add monthly newsletter, member guest posts
 - Member view versus public view

Telegram:

- Public Telegram Channel
 - Vote to close public channel
 - Make notes of current members in the group
 - Notify current subscribers that it is closing soon
 - Best to get new website live first, then promote, then close Telegram group
- Rocky Mountain Bitcoin (RMB) Telegram Group will be new marketing endeavor for member development
- Collect money from those who initially paid, and design protocol for how to remove those who won't respond or pay due balances

Onboarding Process:

- Fine-tune process
 - Prospective member applies, we approve (fit for community?), they pay
 - Ideally have website track this process and verify via BTC payserver
 - Current Form: name, email, how did you hear about us
 - Add qualifying question: What's your Bitcoin thesis?
 - Helps understand their level of Bitcoin knowledge to tailor future events

- 1x per week update
- Reminders
- Happenings
- The Space Weekly (or bi-weekly) Transmission

Future Board Meetings:

- Create protocol for general layout (2-hour limit)
- Poll things to discuss at each meeting
- Categorize into Urgent, Important, Not Important quadrants
- Open Action Items
